Topic: The Economy - How We Can Make BC Number One Again

October 20, 1998 Meeting - Attendance 117.

President Pidge McBride called the meeting to order at 9:59 a.m. He introduced the new Executive to the membership.

"No Dividend" Wallace reported that approximately 50 percent of the members have paid their 1998-1999 dues.

John Hopkins, membership, reported that three new members had signed up at this meeting. All the guests were introduced to the meeting.

Our guest speaker, Norman D. Mullins, Q.C. was introduced by Ken Weaver and thanked by Roy Williams. Mr. Mullins spoke on the Nisga'a Settlement: Lies and Deceptions," in detail and at length. The Treaty can be divided into three sections: Land, Money and Self-Government.

- a) Land: The Treaty covers 1992 sq. km. (492,000 acres or 770 sq.mi. a lot!) and is equivalent to the area from Point Grey to Langley and from the Border to Grouse Mountain. The Nisga'a would own this land fee simple and control the resources. Note that the Nisga'a people total approximately 6000.
- b) Money: The money payout is stated at \$312,000,000 but will probably increase over time with inflation, interest, etc.
- c) Government: The agreement is not comparable to B.C. municipal government because Nisga'a Law will prevail over Provincial and Federal law except for criminal matters.

Mr. Mullins concluded that the court challenge is premature because there is currently no law in place to challenge.

The meeting adjourned at 11:25 a.m.

Remember our CHRISTMAS LUNCHEON on December 15th. This would be an excellent time to introduce a new 'friend' and member, we hope.



## GORDON CAMPBELL MLA for Vancouver - Point Grey Leader of the Official Opposition

There is no mystery about how Gordon Campbell got to be where he is today. Hard work.

It started with a scholarship to Dartmouth College in New Hampshire where in addition to his studies he worked in the dining hall to make extra money.

Shortly after graduation, he and his wife Nancy left for a two-year CUSO teaching assignment in Nigeria where Gordon also helped out the kids by coaching sports on the side.

When Gordon returned home to British Columbia he started as assistant to the Mayor of Vancouver and ultimately three terms as Mayor himself, including a term as president of the Union of BC Municipalities. It was noted by Macleans Magazine that under Mayor Campbell Vancouver was "the most progressive and openly accountable civic administration in the country."

Gordon Campbell was elected Leader of the BC Liberals in 1993.

Gordon now leads the largest Official Opposition in BC history.
