Minutes from November 21, 2000

Attendance 115 including three guests

President John Hopkins opened the meeting at 10:01. He was pleased that most of the returned questionnaire forms contained positive comments. We have received 190 renewals of membership with 30 more to come. He gave praise to Brice Macdougall for his excellent choice of speakers. Several volunteers have come forward to take on the job of Historian. The Presidents Luncheon will be on January 16, 2001 at the Point Grey Golf and Country Club. Dick Matthews urged that the outstanding questionnaires be submitted immediately. Fred Cotton's Vancouver book sales have gone well. There are more available @ \$10.00 each. Brice Macdougall announced that the next speaker would be Rotarian Greg Steele. The next meeting of the Executive will be held Tuesday, November 28th.

The guest speaker, Kari Simpson, was born in California of Canadian parents and left there for Canada at age 14. In her early years she worked as a commercial pilot.

She founded the <u>Citizen's Research Institute</u>
12 years ago. This privately funded registered non
profit organization was an amalgam of several groups
who had concerns regarding freedoms in Canada in
the areas of constitutional, legal, social and medical
issues. The organization initially was involved with

what was perceived as improper apprehension of supposedly abused children by zealous government social workers but has broadened its scope to focus on the changing identity of Canada. This change she feels has a lot to do with the educational systems failure to make democracy work.

One result is that special interest groups have flourished and have become very powerful with the help of government support and funding. An example is the "Child Protection Industry" which has developed into a multitude of government funded bureaucracies with tentacles which reach into all aspects of our lives. Since this has produced a large block of voting civil servants, governments in power are unwilling to dismantle them. Control and compliance are the hallmark of these agencies. One example of inappropriate administration of programs is that teachers are administering sexual abuse programs which have not been developed by professionals and which are based on predetermined guilt.

The CARE PROGRAM teaches children that those closest to them could be those who could harm them by such things as inappropriate touching despite the fact that most parents are raising their children in an appropriate manner. The children are advised to report any such suspicious behavior to their teacher. Most small children cannot differentiate between that which is or is not appropriate and there are many inappropriate reports given by confused children. There is no protection for parents and care givers in the legislation. The complainant is never identified so parents have fewer protections than criminals. As a result a generation of parents have become afraid to discipline their children for fear of being reported to these agencies. Children can be apprehended even if there is only a "likelihod" of harm occurring. A lot of apprehensions are done to middle class families because the case workers don't like working with the hard case lower classes.

Historically there are more children in foster care than ever before. About \$2 billion per year

is spent provincially by the Ministry for Children and Families which supports an army of bureaucrats, counselors, social workers, lawyers and judges. Things have worsened with the NDP being in power. The Citizens Research Institute has put out a declaration of family rights which asks that parents be given the right to control the content of the moral education of their children. This in part has been propelled by the fact that classroom discussion has moved from "tolerance" to "advocacy" in attitudes and presentations on morality. This is allowed under the guise that parents delegate authority to teachers in the upbringing of their children. She feels that the state is ill equipped to deal in the area of personal morality and therefore children should receive this type of education in the home.

Her views conflict with those of the radical fringe in such areas as homosexuality, euthanasia and abortion. As a result, some of her presentations have been the subject of violent demonstrations.

After a question period the speaker was thanked by Al Baker for her interesting and informative talk.

ALERT - ALERT - ALERT

Dear Probus Member:

We are aware of this scam. I have verified this with TELUS security that the 809 scam is indeed true. This scam warning is being distributed all over the U.S. It is pretty scary - especially given the way they try to get you to call.

This scam has been identified by the National Fraud Information Center and is costing victims a lot of money. There are lots of different permutations of this scam, but here's how it works:

You will receive a message on your answering machine or your pager, which asking you to call a number beginning with area code 809. The reason you're asked to call varies. It can be to receive information about a family member who has been ill; to tell you someone has been arrested or died; or to let you know you have won a wonderful prize, etc.

In each case, you are told to call the 809 number right away. Since there are so many new area codes these days, people unknowingly return these calls. If you call from the U.S., you will apparently be charged \$2,425 per minute. Or, you'll get a long recorded message. The point is, they will try to keep you on the phone for as long as possible to increase the charges. Unfortunately, when you get your phone bill, you will often be charged more than \$24,100.00.

The 809 area code is located in the British Virgin Islands (the Bahamas). It can be used as a "pay-per-call" number, similar to the 900 numbers in the U.S. Since 809 is not in the U.S., it is not covered by U.S. regulations of 900 numbers, which requires that callers be notified and warned of charges and rates involved when you call a "pay-per-call"

number. There is also no requirement that the company provide a time period during which the caller may terminate the call without being charged.

Further, whereas many U.S. phones have 900 number blocking to avoid these kinds of charges, 900 number blocking will not prevent calls to the 809 area code.

We recommend that no matter how you get the message, if you are asked to call a number with an 809 area code that you don't recognize it; investigate further and/or disregard the message. Be wary of e-mail or calls asking you to call an 809 area code number. It is important to prevent becoming a victim of this scam, since trying to fight the charges afterwards can become a real nightmare. That's because you did actually make the call. Your local and long distance carrier will most likely tell you that they are simply providing the billing for the foreign company. You will end up dealing with a foreign company that argues they have done nothing wrong


