Minutes from July 17, 2001

Attendance: 93 and 6 guests

President John Hopkins opened the meeting at 10:00 AM by referring to greeters, Laurie Maranda and Neil Gray. Copies of the roster available at back of room. George Adams coordinated the preparation of the new roster. Fred Cotton announced that the August speaker will be Mike Rosenberg, Director of Corporate Development of Ballard Power. Dick Mathews advised there was a short membership wait list. Doug Lambert reported that there were still one or two vacancies on the B.C. Rail Lillooet trip. Peter Farrell, President of the Probus Club in Suburban Perth, Western Australia was introduced as a special guest by President Hopkins.

George Adams introduced the guest speaker Captain Gordon Houston, President of Vancouver Port Authority.

Captain Houston started his talk by pointing out that the Port was a complex entity, the largest port in Canada (larger than Montreal, St. John and Halifax combined) the economic port of Saskatoon and the Western Port of Ontario. 76 million tons passed through Port in 2000. Delta Port was built by Port and containers are the way of

moving cargo with bulk cargo being less and less a factor.

The Port stretches from international border (Pt. Roberts), Point Atkinson and all water east (separate Ports govern Fraser River - North and South).

Port had one million containers in 1999. 1.6 million in 2000. 18 consecutive years of growth. One million cruise passengers reached in 2000.

Alaskan cruise ship business has reached plateau and we should be careful not to get too far ahead with infrastructure.

Canada Marine Shipping Act enacted in 1999 led to commercializing Canada's 18 largest ports. Capt. Houston gave the example of the bureaucratic problems involved in converting Ballentyne Pier to a cruise terminal (back and forth negotiation between local Port authority and Ottawa) and expansion of Canada Place (financing arranged in weeks).

Percentage of Canadian cargo moving, through Seattle down to about 5% with Vancouver's share of West Coast Ports' market being around 37%.

Vancouver was largest North America Port in tonnage until amalgamation of Houstons and Louisiana's Ports. New York now North America's largest. 81% of Vancouver's cargo now mainly resources (grain, coal, potash, sulphur) and some 93 products being exported to some 120 countries. 17,000 directly employed in and about Port. \$75,000,000 in wages and salaries. \$30 billion in trade for Canada per year.

Historian and Archivist Peter McCabe 224-4870 The Port of Canada realize \$500,000,000 in taxes from the above but having to deal with 8 municipalities and Federal and Provincial governments. Expansion between Vancouver and Seattle (Port of Seattle can raise revenue through taxes and bond issues - not Vancouver).

Three scientists on Port staff. Environmentally creative structures e.g. holes in underpinnings of Centerm, troys under Ballentyne, concrete pipe off Cates Towing all providing habitat refuge.

Enforcing regulations against ballast dumping (e.g. can't dump in Vancouver Port unless can show sea water in ballast i.e. ballast dumped in course of voyage). Continuing problems with surrounding municipalities taxing the infrastructure (largely on Federal land) resulting in Municipal taxes exceeding amortization over a 20 year period. Time spent speaking, negotiating, and dealing with surrounding municipalities. North Shore second largest Port in Canada.

Perception is labour in Port is volatile but only 3 days lost in last 3 years as a result of stoppages by Port orders. Fifty different labour contracts in Port.

Change in policing from Federal (27 policemen) to local (agreement with Attorney General to cover 150K in Port from Lions Gate to 2nd Narrows with municipal police forces) with private security handling security for Port.

Made reference to consulting work done by Port for other Ports and the technological changes rapidly occurring e.g. computers running everything in Port miles away. The re-thinking of everything e.g. traditional docks (acres of storage - use of land - floating docks - angled docking, transportation, night operation). Centerm has 7,000 containing capacity but there are works now with 9,000 and on drawing boards for 12,000.

Questions:

- Comparison between Seattle/Tacoma and Port e.g. number of cranes
- long range planning/technology
- Revenue-fixed amount payment to Federal government, rest plowed back to Port
- Delta/trucking/nightime
- containers/empties/not balance/empties flow westbound/full eastbound
- tonnage of port not that much change over past 7 years but shift from bulk to container
